The first Interest Payment Date shall be the date falling one calendar quarter after the First Issue Date, i.e. in 3 June 2022.

The last Interest Payment Date shall be the Final Maturity Date (or such earlier date on which the Bonds are redeemed in full).

To the extent any of the above dates is not a Business Day, the first following day that is a Business Day, unless that day falls in the next calendar month, in which case that date will be the first preceding day that is a Business Day.

Interest Periods:

Interest on the Initial Bonds will accrue from, but excluding, the First Issue Date to, and including, the first Interest Payment Date. Any subsequent interest periods will be the period from, but excluding, an Interest Payment Date to, and including, the next succeeding Interest Payment Date (or a shorter period if relevant).

Any Subsequent Bonds will carry interest at the Interest Rate from, but excluding, the Interest Payment Date falling immediately prior to their issuance to, and including, the next succeeding Interest Payment Date (or a shorter period if relevant).

Interest Payment:

Interest shall be payable quarterly in arrears on the Interest Payment Dates each year.

Calculation of interest:

Interest shall be calculated on the basis of the actual number of days in the interest period in respect of which payment is being made divided by 360 (actual/360).

Default Interest:

Five (5) per cent. higher than the Interest Rate.

Accrued Default Interest shall not be capitalised. No Default Interest shall accrue where the failure to pay was solely attributable to the Agent or the CSD, in which case the Interest Rate shall apply instead.

Price:

100.00 per cent. of the Initial Nominal Amount for Bonds issued on the First Issue Date, provided that the Bonds may also be sold at a price below par to larger investors, in which case any difference shall be reduced from the Arranger's arrangement fee.

Subsequent Bonds may be issued at, above or below par.

Nominal Amount: The nominal amount of each SEK Bond will be SEK 10,000 and of each EUR Bond will be EUR 1,000.

Minimum Investment: The minimum investment upon issuance of the Bonds is SEK 1,100,000 (or at least the SEK equivalent of EUR 100,000) and EUR 100,000 respectively.

Purpose and status

Purpose of the Bond Issue: The proceeds from the Initial Bond Issue shall be used to:

- (a) finance the acquisition of the Target Companies;
- (b) finance working capital and general corporate purposes, including investments and acquisitions;
- (c) refinancing, in whole or in part, of the Senior Financing and/or the Construction Facilities; and
- (d) finance Transaction Costs.

The proceeds from any Subsequent Bond Issue shall be used to:

- (a) finance the acquisition of the Target Companies;
- (b) finance working capital and general corporate purposes, including investments and acquisitions;
- (c) refinancing, in whole or in part, of the Senior Financing and/or the Construction Facilities; and
- (d) finance Transaction Costs.

The Target Companies may be acquired on an individual basis on several occasions.

Status of the Bonds: The Bonds constitute direct, general, unconditional, unsubordinated and secured obligations of the Issuer and shall at all times rank (i) without any preference among them and (ii) at least *pari passu* with all direct, unconditional, unsubordinated and unsecured obligations of the Issuer, except those obligations which are mandatorily preferred by law.

Subordination Agreement: Any claims under any Subordinated Loans shall be fully subordinated to the Bonds, including with respect to payments (maturity and instalments), tenure and enforcement proceeds under a subordination agreement in form and substance acceptable to the Agent (acting reasonably).

Guarantees and Security

Guarantee:

The Guarantor will irrevocably and unconditionally, jointly and severally, as principal obligor, guarantee to the Bondholders and the Agent the punctual performance by the Issuer of all the Issuers' obligations under the Finance Documents (to the fullest extent permitted under applicable laws).

Transaction Security:

All amounts outstanding under the Finance Documents, including but not limited to the Bonds, plus accrued interests and expenses shall be secured by the following Security on the terms set out in the relevant security agreements:

- (a) a Danish law governed first priority pledge over all the shares in the Issuer granted by Oskar Group ApS;
- (b) a Danish law governed first priority pledge over all the shares in each PropCo, once established or acquired;
- (c) a Danish law governed first priority pledge over any current and future Downstream Loans; and
- (d) a Danish law governed first priority pledge over the Blocked Account.

Junior Ranking Transaction Security

If required by (a) a lender under a Senior Financing or (b) a lender under a Construction Facility, the Issuer is entitled to grant senior ranking security over all shares in the relevant PropCo and mortgages in the relevant Properties to such financiers, in which case the Bondholders are obliged (without any further approval processes) to relinquish its first priority pledge over the shares in the relevant PropCo granted under item (b) of the definition of Transaction Security and instead accept a junior ranking pledge over the shares in the relevant PropCo if allowed by the lender under (a) a Senior Financing or (b) a Construction Facility, in each case subject to market standard intercreditor terms, described below under Intercreditor Agreement.

The Issuer shall inform the Bondholders if any first priority share pledge granted under item (b) of the definition of Transaction Security is to be converted into junior ranking security and shall procure that the relevant documentation and perfection are executed and performed.

Additional Security over new Downstream Loans:

Upon the granting of any new Downstream Loan, the Issuer shall, to the extent not already covered by existing pledge agreements, pledge such Downstream Loan as a first priority security for all amounts outstanding under the Finance Documents in favour of the Security Agent and simultaneously therewith deliver to the Agent constitutional documents and corporate resolutions (approving the relevant Security Document and authorising a signatory/-ies to execute the relevant Security Document) for the Issuer.

Upon the granting of a Downstream Loan, the Issuer undertakes to notify the Agent of such Downstream Loan and deliver a copy of the intercompany loan agreement.

Provided that no Event of Default has occurred and is continuing, payment of interest or principal under Downstream Loans ("**Upstream Payments**") may take place in each of the following situations:

- (a) for the purpose of servicing the Issuer's payment obligations under the Bonds;
- (b) subject to the provisions set out below, in connection with a permitted disposal of 100 per cent. of the shares in a PropCo; and
- (c) otherwise with the written consent of the Security Agent.

If a PropCo wishes to repay a Downstream Loan under paragraph (b) above, the repayment amount must be paid by the PropCo into the Blocked Account.

Redemption and call structure

Redemption at Final Maturity Date:

On the Final Maturity Date, the Issuer shall redeem all, but not only some, of the outstanding Bonds in full with an amount per Bond equal to the Nominal Amount together with accrued but unpaid interest.

Purchase of Bonds by the Issuer:

The Issuer may at any time and at any price purchase any Bonds on the market or in any other way. Bonds held by the Issuer may at the Issuer's discretion be retained, sold or cancelled.

Voluntary total redemption – Call Option (American):

The Issuer may redeem all, but not only some, of the Bonds early on any Business Day before the Final Maturity Date. The Bonds shall be redeemed at the Call Option Amount together with accrued but unpaid interest.

Call Option Amount:

- (a) if the Call Option is exercised before the date falling 12 months after the First Issue Date at an amount per Bond equal to the sum of (i) 100 per cent of the Nominal Amount and (ii) the remaining interest payments on or after the First Issue Date to, but not including, the date falling 12 months after the First Issue Date; and
- (b) if the Call Option is exercised on or after the date falling 12 months after the First Issue Date to, but not including, the Final Maturity Date at an amount per Bond equal to 100 per cent. of the Nominal Amount.

For the purpose of calculating the remaining interest payments pursuant to (a) above it shall be assumed that the Interest Rate for the period from the relevant record date to but not including, the date falling 12 months after the First Issue Date will be equal to the Interest Rate in effect on the date on which notice of redemption is given to the Bondholders. The relevant record date shall be agreed upon between the Issuer, the CSD and the Agent in connection with such repayment.

Mandatory Repurchase Due to a Change of Control Event (put option):

Upon the occurrence of a Change of Control Event, each Bondholder shall have the right to request that all, or some only, of its Bonds be repurchased at a price per Bond equal to 101 per cent. of the Nominal Amount together with accrued but unpaid interest according to the Call Option Amount, during a period of 20 Business Days following a notice from the Issuer of the Change of Control Event (after which time period such rights lapse). The Redemption Date must fall no later than 40 Business Days after the end of the period of 20 Business Days referred to above.

Voluntary partial redemption:

Any proceeds from a disposal that has not been applied towards a Permitted Acquisition can be applied towards a partial redemption of the Bonds.

The repayment per Bond shall be equal to the repaid percentage of the Nominal Amount (rounded down to the nearest SEK or EUR 1.00).

Escrow Account and distribution of Net Proceeds**Escrow Account:**

The Net Proceeds from a Bond Issue shall be held by the Arranger on the Escrow Accounts and shall be released when the Conditions Precedent for Disbursement or Conditions Precedent for

Disbursement in connection with Subsequent Bond Issues (as applicable) have been fulfilled.

Conditions Precedent for Disbursement:

The Agent's approval of the disbursement of the Net Proceeds from the Escrow Account is subject to the documents in paragraphs (a) – (j) below (as applicable) have been received by the Agent. For the avoidance of doubt, Net Proceeds may be partially released, to acquire one Target Company, provided that the conditions precedent relating to that Target Company are fulfilled.

- (a) constitutional documents and corporate resolutions (approving the relevant Finance Documents and authorising a signatory/-ies to execute the Finance Documents) for the Issuer and each other party to a Finance Document (other than the Agent), together constituting evidence that the Finance Documents have been duly executed;
- (b) copies of the Finance Documents, duly executed;
- (c) evidence that the Transaction Security either has been or will immediately following disbursement from the Escrow Account be perfected in accordance with the terms of the Finance Documents;
- (d) closing certificate signed by the Issuer confirming that all closing conditions for the acquisition of the applicable Target Company/ies (except for the payment of the purchase price) have been satisfied or waived and that the acquisition will be consummated immediately upon disbursement of funds from the Escrow Account;
- (e) an agreed form Compliance Certificate evidencing that the Incurrence Test will be met upon release of the Net Proceeds;
- (f) the Initial Valuation(s) of the relevant Property/ies owned by a Target Company;
- (g) if applicable, Valuation(s) of the relevant Property/ies;
- (h) if applicable, documentation setting out the Allocated Bond Amount for each Property to be directly or indirectly acquired with Net Proceeds;

- (i) legal opinion(s) on the capacity and due execution of a party (other than the Agent) to a Finance Document issued by a reputable law firm; and
- (j) legal opinion(s) on the validity and enforceability of any Finance Document not governed by Swedish law issued by a reputable law firm.

The Issuer may acquire the Target Companies separately.

When the conditions precedent for disbursement set out above have been fulfilled to the satisfaction of the Agent (acting reasonably) or waived by the Agent, the Agent shall notify the Arranger that the Net Proceeds may be released from the Escrow Accounts, to be applied as set out in Section "*Purpose of the Bond Issue*" above and in accordance with the instructions of the Arranger.

The Agent may assume that the documentation and evidence delivered to it is accurate, legally valid, enforceable, correct, true and complete unless it has actual knowledge to the contrary and the Agent does not have to verify or assess the contents of any such documentation. The conditions precedent are not reviewed by the Agent from a legal or commercial perspective of the Bondholders.

If the Conditions Precedent for Disbursement have not been fulfilled to the satisfaction of the Agent (acting reasonably) or waived by the Agent within sixty (60) Business Days from the First Issue Date, the Issuer shall repurchase all Bonds at a price equal to 100 per cent. of the Initial Nominal Amount together with any accrued Interest. The funds on the Escrow Account shall in such case be applied to redeem the Bonds on behalf of the Issuer. Any shortfall shall be covered by the Issuer. The repurchase date shall fall no later than thirty (30) Business Days after the ending of the sixty (60) Business Days period referred to above.

Disbursement from the Blocked Account:

The Issuer may request that all or parts of the funds deposited on the Blocked Account are disbursed by requesting such disbursement from the Agent, accompanied with reasonable evidence showing that the disbursed funds will be applied towards one or several of the following:

- (a) financing a Permitted Acquisition;

- (b) a voluntary partial redemption of the Bonds in accordance with the Terms and Conditions of the Bonds; and/or
- (c) development of existing and/or acquired Properties.

Publication and availability of Finance Documents:

The Issuer shall keep the latest version of the Terms and Conditions available on the website of the Group.

The latest version of the Finance Documents (other than the Agency Agreement) shall be available to the Bondholders at the office of the Agent during the Agent's normal business hours.

The Terms and Conditions shall be available on the website of the Agent.

Financial Undertakings

Incurrence Test:

The Incurrence Test is met if:

- (a) the Loan to Value is not greater than 85 per cent.; and
- (b) no Event of Default is continuing or would occur upon the incurrence of new Financial Indebtedness or disposal (as applicable).

Calculation of Incurrence Test:

Calculation of the Loan to Value

The owner may inject equity or Subordinated Loans into the structure prior to testing the Incurrence Test in order to meet the test before making a Subsequent Bond issue (to be recalculated so that the Net Interest Bearing Debt is reduced with an amount equivalent to the amount injected).

The calculation of the Loan to Value for the purpose of the Incurrence Test shall be calculated as follows:

- (a) the calculation of Net Interest Bearing Debt shall be as per a testing date determined by the Issuer, falling no more than one month prior to the incurrence of the new Financial Indebtedness (as applicable) and the amount of Net Interest Bearing Debt shall be measured on the relevant testing date so determined, but include any new Financial Indebtedness and exclude any Financial Indebtedness to the extent refinanced with the new Financial Indebtedness incurred (however, any cash balance resulting from the incurrence of any new Financial Indebtedness shall not reduce the Net Interest Bearing Debt); and
- (b) the calculation of Value shall be calculated based on the most recent Valuation.

General Undertakings

The Terms and Conditions shall include the following undertakings by the Issuer.

Restricted Payments:

The Issuer shall not, and shall procure that none of its Subsidiaries (unless to the Issuer) will:

- (a) pay any dividend in respect of its shares;
- (b) repurchase or redeem any of its own shares;
- (c) redeem or reduce its share capital or other restricted or unrestricted equity with repayment to its shareholders;
- (d) repay any Subordinated Debt or pay any interest thereon;
- (e) make any prepayments or repayments under any long-term debt ranking junior or *pari passu* with the Bonds (other than any prepayment or repayment of Senior Financing or Construction Facilities);
- (f) grant any loans except in the ordinary course of business ; and
- (g) make any other similar distribution or transfers of value to any Person.

Notwithstanding the above, dividends and/or payments in an aggregate amount not exceeding the amount of proceeds from the Guarantor's preference share issue that has been down-streamed or contributed to the PropCos shall be permitted to be up-streamed back to the Guarantor (without double-counting with any upstream loans made for the same purpose).

Nature of business:

The Issuer shall procure that no substantial change is made to the general nature of the business carried on by the Group as of the First Issue Date if such substantial change would have a Material Adverse Effect.

Financial Indebtedness:

The Issuer shall, and shall procure that none of its Subsidiaries will, incur any Financial Indebtedness, other than Permitted Debt.

Disposals of assets:

The Issuer shall not, and shall procure that none of its Subsidiaries will, sell or otherwise dispose of any business, assets, PropCo or Property unless:

- (a) the transaction is carried out at fair market value and on arm's length terms; and

(b) an amount equal to the Allocated Bond Amount with respect to the disposed Property is deposited on the Blocked Account.

Negative pledge:

The Issuer shall not, and shall procure that none of its Subsidiaries will, provide, prolong or renew any security over any of its/their assets (present or future), other than any Permitted Security.

Loans Out:

The Issuer shall procure that itself and the Group Companies do not extend any loans in any form to any other party than to a PropCo.

Notwithstanding the above, up-stream loans in an aggregate amount not exceeding the amount of proceeds from the Guarantor's preference share issue that has been down-streamed or contributed to the PropCos shall be permitted to be made to the Guarantor (without double-counting with any dividends made for the same purpose).

Mergers and demergers:

The Issuer shall procure that none of its Subsidiaries will enter into a merger or demerger unless such merger constitutes a Permitted Merger.

Dealings at arm's length terms:

The Issuer shall, and shall procure that its Subsidiaries, conduct all dealings with any person (other than Group Companies) at arm's length terms.

Compliance with laws and authorisations:

The Issuer shall, and shall make sure that its Subsidiaries will (i) comply with all laws and regulations applicable from time to time, and (ii) obtain, maintain, and comply with, the terms and conditions of any authorisation, approval, licence or other permit required for the business carried out by a Group Company, in each case, if failure to do so has or is reasonably likely to have a Material Adverse Effect.

Insurance:

The Issuer shall, and shall procure that its Subsidiaries will, keep the Properties insured to an extent which is customary for similar properties on the relevant geographical market with one or more reputable insurers. The insurance cover shall *inter alia* include full value insurance and loss of rent insurance.

Environmental:

The Issuer shall, and shall ensure that its Subsidiaries will, comply with all environmental laws and obtain, maintain and ensure compliance with all requisite

environmental permits, if failure to do so has or is reasonably likely to have a Material Adverse Effect.

Property specific undertakings:

The Issuer shall ensure that:

- (a) the Properties are managed properly and maintained in good condition; and
- (b) the Properties are not demolished or altered in a way that would have a Material Adverse Effect.

Events of Default

(a) **Non-payment:** The Issuer or Guarantor fails to pay an amount on the date it is due in accordance with the Finance Documents unless:

- (i) its failure to pay is caused by administrative or technical error; and
- (i) payment is made within five (5) Business Days of the due date.

(b) **Other obligations:** A party (other than the Agent) fails to comply with the Finance Documents, in any other way than as set out under (a) above, provided that no Event of Default will occur if the failure to comply is capable of being remedied and the Issuer or the party has remedied the failure within fifteen (15) Business Days of the earlier (i) the Issuer or that party becoming aware of the failure to comply and (ii) the Agent requesting the Issuer in writing to remedy such failure.

(c) **Cross payment default and Cross-acceleration:** Any Financial Indebtedness of a Group Company is:

- (i) not paid when due as extended by any originally applicable grace period (if there is one); or
- (ii) is declared to be due and payable prior to its specified maturity as a result of an event of default (however described),

provided that no Event of Default will occur under this paragraph (c) if (i) the aggregate amount of Financial Indebtedness that has fallen due is less than DKK 5,000,000 or (ii) it is owed to a Group Company.

(d) **Insolvency:**

- (i) Any Group Company is unable or admits inability to pay its debts as they fall due or is declared to be unable to pay its debts under applicable law, suspends making payments on its debts generally or, by reason of actual or anticipated financial difficulties, commences negotiations with its creditors (except for Bondholders) with a view to rescheduling its Financial Indebtedness; or
 - (ii) a moratorium is declared in respect of the Financial Indebtedness of any Group Company.
- (e) **Insolvency proceedings:** Any corporate action, legal proceedings or other procedures are taken (other than (i) proceedings or petitions which are being disputed in good faith and are discharged, stayed or dismissed within 60 days of commencement or, if earlier, the date on which it is advertised and (ii), in relation to Subsidiaries of the Issuer not being subject to Transaction Security, solvent liquidations) in relation to:
 - (i) the suspension of payments, winding-up, dissolution, administration or reorganisation (by way of voluntary agreement, scheme of arrangement or otherwise) of any Group Company; and
 - (ii) the appointment of a liquidator, receiver, administrator, administrative receiver, compulsory manager or other similar officer in respect of any Group Company or any of its assets or any analogous procedure or step is taken in any jurisdiction.
- (f) **Creditors' process:** Any expropriation, attachment, sequestration, distress or execution or any analogous process in any jurisdiction affects any asset or assets of any Group Company having an aggregate value of an amount equal to or exceeding DKK 5,000,000 and is not discharged within 60 days.
- (g) **Mergers and demergers:** A decision is made that the Issuer shall enter into a merger where

it is not the surviving entity or that is shall enter into a demerger.

- (h) **Impossibility or illegality:** It is or becomes impossible or unlawful for the Issuer or any Group Company to fulfill or perform any of the provisions of the Finance Documents or if the obligations under the Finance Documents are not, or cease to be, legal, valid, binding and enforceable.
- (i) **Continuation of the business:** The Issuer or any other Group Company ceases to carry on its business if such discontinuation is likely to have a Material Adverse Effect.

Allocation of Proceeds:

All payments by the Issuer relating to the Bonds and proceeds received from an enforcement shall (in the case of the Guarantees to the extent proceeds from the Guarantees can be applied towards satisfaction of the below) be made and/or distributed in the following order of priority:

- (a) *first*, in or towards payment of the Agent under the Finance Documents, including all costs and indemnities relating to the acceleration of the Bonds or the protection of the Bondholders' rights under the Finance Documents;
- (b) *secondly*, towards payment of accrued interest unpaid under the Bonds;
- (c) *thirdly*, towards payment of principal under the Bonds; and
- (d) *fourthly*, in or towards payment of any other costs or outstanding amounts under and in respect of the Bonds.

Any excess funds after the application of proceeds in accordance with paragraphs (a) to (d) above shall be paid to the Issuer (or the Guarantor, as applicable).

Acceleration amount:

In the event of an acceleration of the Bonds, the Issuer shall redeem all Bonds with the applicable Call Option Amount per Bond as set forth in the "*Call Option Amount*" above.

CSD: The Issuer's central securities depository and registrar in respect of the Bonds from time to time, initially Euroclear Sweden AB, reg. no. 556112-8074, P.O. Box 191, 101 23 Stockholm, Sweden.

Miscellaneous

Intercreditor Agreement: The Issuer, the Agent, the Security Agent and a lender under a Senior Financing and/or Construction Facility may (and shall if required by a lender under a Senior Financing and/or Construction Facility) enter into an intercreditor agreement to regulate the manner of enforcement of the Transaction Security pursuant to which the Transaction Security granted under item (b) of the definition of Transaction Security may become junior ranking pledges. The intercreditor agreement may contain other customary terms such as:

- (a) agreed stay periods before the junior ranking pledgee may begin enforcing;
- (b) turnover of amounts not permitted to be received;
- (c) voting provisions and exercise of voting rights;
- (d) first ranking pledgee's right to instruct the agent or enforce the pledge;
- (e) security enforcement objectives; and
- (f) security agent's right to release the relevant Transaction Security.

The Security Agent will be authorised to enter into any such agreements on behalf of the Bondholders as required.

Quorum and majority requirements: Quorum at a Bondholders' meeting exists only if Bondholders representing at least 20 per cent. in case of a majority decision and 50 per cent. in case of a decision requiring qualified majority, of the aggregate Nominal Amount attend the Bondholders' meeting in due order.

Bonds held by the Issuer or its Affiliates shall not be considered when calculating if necessary majority

has been achieved and shall not carry any voting right.

The resolution of the Bondholders shall be in accordance with the opinion held by the majority of the Nominal Amount of the Bonds represented at the meeting.

In respect of the certain matters, a qualified majority of at least two thirds (2/3) of the Bonds represented at the meeting is required for a resolution to be passed.

If the quorum requirement has not been met, no quorum requirement applies in the second meeting.

Voting:

Notwithstanding anything to the contrary above, at a bondholders' meeting or by way of a written procedure, the calculations of whether a quorum exist and if the relevant consent has been obtained, shall be made in SEK. Each Bond shall always entitle to one vote at a bondholders' meeting or by way of a written procedure. The value of the vote of each SEK Bond shall be the Nominal Amount and the value of the vote of each EUR Bond shall be the Nominal Amount of the EUR Bond converted into SEK at the Initial Exchange Ratio. For the avoidance of doubt, the Adjusted Nominal Amount shall at all times be calculated based on the Initial Exchange Ratio.

No action clause:

No Bondholder may take any action against the Issuer in matters relating to the Bonds or the Terms and Conditions.

Terms and Conditions:

The Terms and Conditions will regulate the rights and obligations with respect to the Bonds. In the event of any discrepancy between this term sheet and the Terms and Conditions, the Terms and Conditions shall prevail.

By investing in the Bonds, each investor accepts to be bound by the Terms and Conditions. Further, by investing in the Bonds each investor accepts that certain adjustments to the structure and terms described in this term sheet may occur and that they are bound by the final terms of the Terms and Conditions.

The Terms and Conditions shall include provisions on the Agent's right to represent the Bondholders, as well as other provisions customary for a Nordic bond offering.

Governing law and disputes:

The Terms and Conditions shall be governed by and construed in accordance with Swedish law. The Transaction Security will be governed by Danish law.

Any dispute or claim arising in relation to the Terms and Conditions shall be determined by Swedish courts.

DEFINITIONS

"Advance Purchase Agreements" means (a) an advance or deferred purchase agreement if the agreement is in respect of the supply of assets or services in the normal course of business with credit periods which are not longer than 90 days after the supply of assets or services, or (b) any other trade credit incurred in the ordinary course of business when payment is due no more than 90 days of the date of trade.

"Affiliate" means any Person, directly or indirectly, controlling or controlled by or under direct or indirect common control with such specified Person. For the purpose of this definition, **"control"** when used with respect to any Person means the power to direct the management and policies of such Person, directly or indirectly, whether through the ownership of voting securities, by contract or otherwise; and the terms **"controlling"** and **"controlled"** have meanings correlative to the foregoing.

"Allocated Bond Amount" means:

- (a) with respect to the Blegdamsvej Property, an amount equal to DKK 60,000,000;
- (b) with respect to the Købmagergade Property, an amount equal to DKK 65,000,000;
- (c) with respect to the Østergade Properties, an amount equal to DKK 40,000,000;
- (d) with respect to the Columbusvej PropCo, an amount equal to DKK 80,000,000;

"Agency Agreement" means the fee agreement entered into between the Agent and the Issuer on or prior to the First Issue Date regarding, *inter alia*, the remuneration payable to the Agent.

"Blegdamsvej Property" means the real property, title no. 95a Udenbys Klædebo Kvarter, København located at Blegdamsvej 124, 2100 København Ø, Denmark.

"Blocked Account" means a bank account in the name of the Issuer held with a reputable bank and pledged to the bondholders as represented by the Agent.

"Bondholder" means the person who is registered on a Securities Account as direct registered owner (Sw. *ägare*) or nominee (Sw. *förvaltare*) with respect to a Bond.

"Bond Issue" means the Initial Bond Issue and any Subsequent Bond Issue.

"Change of Control Event" means the occurrence of an event or series of events whereby one or more persons, not being Hawk Investment ApS (CVR 25 08 32 88) (or an Affiliate of Hawk Investment ApS), acting together, acquire control over the Issuer and where "control" means (a) acquiring or controlling, directly or indirectly, more than 50 per cent. of the voting shares of the Issuer, or (b) the right to, directly or indirectly, appoint or remove all or a majority of the directors of the board of directors of the Issuer.

"Columbusvej Property" means the real property with title no. 12ax, Gladsaxe and 12cd, Gladsaxe, situated at Columbusvej 1 and Columbusvej 3, 2860 Søborg, Denmark and no. 12ce, Gladsaxe, located at Columbusvej 5, 2860 Søborg, Denmark.

"Compliance Certificate" means a certificate to the Agent, in the agreed form between the Agent and the Issuer, signed by the Issuer certifying (as applicable):

- (a) that so far as it is aware no Event of Default is continuing or, if it is aware that such event is continuing, specifying the event and steps, if any, being taken to remedy it; and/or
- (b) if the Compliance Certificate is provided in connection with an Incurrence Test, that the Incurrence Test is met (including figures in respect of the relevant financial tests and the basis on which they have been calculated).

"Construction Facility" means any construction facility incurred by a PropCo to finance the development and construction of any Property owned by such PropCo provided that there shall not be more than one provider of such construction facility in each PropCo.

"Downstream Loans" means any current or future downstream loans from the Issuer to any PropCo.

"Escrow Account" means a SEK bank account and/or EUR bank account opened by the Arranger with a reputable bank on which the proceeds from a Bond Issue will be held until the Conditions Precedent for Disbursement have been fulfilled.

"Finance Documents" means:

- (b) the Agency Agreement;

"Gladsaxe Møllevvej Property" means the real property title no. 14r, Gladsaxe, situated at Gladsaxe Møllevvej 25, 2860 Søborg, Denmark.

"Guarantee Agreement" means the guarantee agreement pursuant to which the Guarantor shall, amongst other, (i) guarantee all amounts outstanding under the Finance Documents, including but not limited to the Bonds, plus accrued interests and expenses, and (ii) agree to subordinate all subrogation claims.

"Guarantee" means the guarantee provided by the Guarantor under the Guarantee Agreement.

"Købmagergade Property" means the real property title no. 79, Klædebo Kvarter, København located at Købmagergade 57, 1150 København K, Denmark.

"Loan to Value" means the Net Interest Bearing Debt to the Value.

"Market Loan" means any loan or other indebtedness where an entity issues commercial paper, certificates, subordinated debentures, bonds or any other debt securities (including, for the avoidance of doubt, medium term note programmes and other market funding programmes), provided in each case that such instruments and securities are or can be subject to trade on any Regulated Market, MTF or any other regulated or unregulated recognised market place.

"Material Adverse Effect" means a material adverse effect on:

- (a) the business, financial condition or operations of the Group taken as a whole;
- (b) the ability of the Issuer to comply with its obligations under the Finance Documents; or

- (g) any Security created for the benefit of the financing providers in relation to a refinancing of the Bonds in full, however provided always that any perfection requirements in relation thereto are satisfied after repayment of the Bonds in full (other than with respect to an escrow account (if applicable) which may be perfected in connection with the incurrence of such debt);
- (h) provided for any guarantees issued by a Group Company in the ordinary course of business;

"Person" means any individual, corporation, partnership, limited liability company, joint venture, association, joint-stock company, trust, unincorporated organisation, government, or any agency or political subdivision thereof or any other entity, whether or not having a separate legal personality.

"PropCo" means;

- (a) Real Danmark Ejendomme I A/S, a limited liability company incorporated in Denmark with CVR number 14450505;
- (b) Real Danmark Ejendomme II ApS, a limited liability company incorporated in Denmark with CVR number 40689923;

- (c) Real Danmark Ejendomme III ApS, a limited liability company incorporated in Denmark with CVR number 40690042;
- (d) Real Danmark Ejendomme IV ApS, a limited liability company incorporated in Denmark with CVR number 41860642;
- (e) Real Danmark Ejendomme V ApS, a limited liability company incorporated in Denmark with CVR number 41860561;
- (f) Real Danmark Ejendomme VI ApS, a limited liability company incorporated in Denmark with CVR number 41845546; and
- (g) any other entity incorporated in Denmark, majority owned and controlled by the Issuer, owning a Property.

"Properties" means:

- (a) the Blegdamsvej Property;

- (e) the Gladsaxe Møllevvej Property;
- (f) the Columbusvej Property; and

"Reference Date" means 31 March, 30 June, 30 September and 31 December in each year for as long as any Bonds are outstanding.

"Regulated Market" means any regulated market as defined in the Markets in Financial Instruments Directive 2014/65/EU (MiFID II), as amended.

"Roskildevej Property" means the real property title no. 20v, Brøndbyøster By, Brøndbyøster, situated at Roskildevej 547, DK-2605 Brøndby, Denmark.

"Secured Parties" means the Bondholders and the Agent (including in its capacity as Agent under the Agency Agreement and in its capacity as security agent).

"Security Documents" means the security documents pursuant to which the Transaction Security is created and any other document designated as a Security Document by the Issuer and the Agent.

"Senior Financing" means any working capital facility agreement, mortgage loan or similar agreement providing financing for general corporate purposes including financing or refinancing of the acquisition of any Property between the Issuer, or a PropCo, and a third party (which is not owned or controlled by the Guarantor).

"Subordinated Debt" means any loan made to the Issuer as debtor, if such loan:

- (a) according to its terms is subordinated to the obligations of the Issuer under the Finance Documents;

- (a) owns shares or ownership rights representing more than fifty (50) per cent. of the total number of votes held by the owners;

"**TARGET Day**" means any day on which the Trans-European Automated Real-time Gros Settlement Express Transfer payment system is open for the settlement of payments in EUR.

"**Transaction Costs**" means all fees, costs and expenses, stamp, registration and other taxes incurred by the Issuer or any other member of the Group in connection with a Bond Issue.

"**Valuation**" means a valuation of the Properties prepared and issued by an independent and reputable appraiser, specifying the Value of the Properties.
